Dear Sir/Madam,

1. Your son/ward \_\_\_\_\_ Roll No \_\_\_\_\_ has been selected for admission to **Class VI/IX** in this school.

2. Keeping in view Nationwide lockdown in the country due to COVID-19, **online provisional admission** will be given to your son/ward subject to his confirming to the age limit given below, online deposit of fee and submission of mandatory admission documents. Candidate who is given **provisional admission** will be called for final admission/joining the school when the school re-opens after COVID-19 crisis.

(a) **Age limit for Class VI.** The date of birth should be between **01 Apr 2008** and **31 Mar 2010** (both days inclusive).

(b) **Age limit for Class IX.** The date of birth should be between **01 Apr 2005** and **31 Mar 2007** (both days inclusive).

3. **Submission of Mandatory Documents through Online.** The following documents are mandatory required for grant of provisional admission. Last date for submission of online documents is **17 Aug 2020 for class VI/IX**. These documents are required to be submitted through email at [sainikschoolrewari@gmail.com](mailto:sainikschoolrewari@gmail.com) properly scanned in PDF format. Incomplete/ineligible documents will not be accepted. In case of any doubt/query, the same may be resolved on **Telephone No. 01274-260850 during 0930 hrs to 1330 hrs** on all working days. Original copy of all documents would be required to be submitted at the time of joining of school :-

(a) Birth certificate of candidate issued by respective State Department of Medical Health & Family Welfare.

(b) Domicile certificate of parent as per format attached as **Appendix 'A'** or already issued by the State Govt authority.

(c) Caste certificate (SC/ST Candidates only) as per format attached as **Appendix 'B'** or already issued by the State Govt authority.

(d) Bio-data and address details as per **Appendix 'C'**.

(e) Copy of Aadhaar Card of Candidate.

(f) Digital photograph of cadet (passport size).

(g) Marks Sheet/Annual Report Card of class last attended.

(h) Transfer certificate from school last studied duly countersigned by District Education Officer (where applicable). In case it is not possible due to lockdown, a certificate from the school as per format attached as **Appendix 'D'**

(j) Service certificate duly signed by the Commanding Officer of the Unit in the case of defence serving personnel.

(k) Ex-servicemen certificate issued by District Sainik Kalyan and Punarwas Officer in the case of ex-serviceman.

(l) Undertaking from the parents with regard to submission of original documents at the time of admission, as per format given at **Appendix 'E'**.

4. **Payment of online Fee.** After submission of documents by the parents as mentioned in Para 3 above, these will be scrutinized by this school and the candidate will be allotted **School Number**. Parents will be informed about acceptance of documents along with School Number of the cadet. After receiving the acceptance of admission, fee to be deposited through **RTGS/NEFT** as under:-

5. Once the fee is credited in the school account, the candidate will be given provisional admission in the school and the same will be intimated to the parents through email/SMS. Receipt for fee can be obtained from the School at the time of joining of the cadet.

6. **Online Classes.** After giving the provisional admission in the school, the cadet will be allowed to join online classes for which the parents would have to intimate their **WhatsApp/Mobile No** in advance. The details of conduct of online classes will be intimated subsequently.

7. **Final Admission/Joining the School.** As all are aware that the schools are closed due to COVID-19, the same will reopen as per directions from the Central/State Govts/Sainik School Society. Accordingly, final date of admission/joining dates of new entrants will be decided by the School and the same will be intimated to the parents through school website [www.ssrw.org](http://www.ssrw.org).

The provisional admission will be cancelled, in case the mandatory criteria is not fulfilled/original documents are not submitted within the stipulated time or any document is found false/incomplete at a later stage, even after confirmation of admission in the school.

**AGREEMENT BETWEEN PARENTS/GUARDIANS  
AND PRINCIPAL, SAINIK SCHOOL REWARI**

1. This agreement is made this.....day of Month..... Year..... between Shri.....(hereinafter called the "Guarantor") which expression shall unless excluded by the context or the meaning thereof be deemed to include his heirs, executors, administrators and legal representatives) of the one part and the Board of Governors, Sainik Schools Society (hereinafter called the "Governors") which expression shall unless excluded by the context of the meaning thereof be deemed to include the Principal, Sainik School Rewari of the other part.

2. Whereas.....Son of.....(hereinafter called the student) is son/ward of the Guarantor and has at the request of the Guarantor been selected for admission to the Sainik School Rewari inter alia, on the terms and conditions hereinafter appearing for the purpose of receiving education with a view to making the Regular Armed Forces his profession in life, if considered by the appropriate authority to be suitable and if there is any vacancy and if he be selected.

3. NOW IT IS HEREBY AGREED BY AND between the parties hereto as follows:

4. That in consideration of the student being admitted by the Governors to the Sainik School for the purpose of the aforesaid education at the request of the Guarantor , covenants with Governors that the student will attend the Sainik School regularly and will observe and comply with all the rules and regulations thereof for the prescribed period or until he is declared fit for admission to any institution as may from time to time be prescribed by the Governors, for training for entry to the Regular Armed Forces and that he, the Guarantor shall pay to the Governors regularly and promptly and when ever called upon to do so all the fees as prescribed , if he is not in receipt of any scholarship.

5. That for any reasons not beyond the control of either the student or the Guarantor the student fails to pursue his studies at the said school before appearing for selection for entry to any institution as may from time to time be prescribed by the Governors for training for entry to the Regular Armed Forces or fails to appear for the said selection or in the event of his not succeeding in the said selection , fails to appear for selection , till such time as his age permits him to do so, according to the rules and regulations.

6. For the time being in force or having been declared successful at the said selection, does not proceed to one of the said institutions to which he may be directed to proceed for being trained for entry into the Regular Armed Forces or having joined the said institutions fails to complete the training thereat for entry into the Regular Armed Forces or fails to join the Regular Armed Forces after completing the training at the said institution, then and if any such case the Guarantor shall forthwith pay to the Governors, in cash, the sum of scholarship the student has received from the school and/or the State government/Central government the value of the scholarship he has received for the period the student was at the said school.

7. That if after admission any of the following viz, proof of Domicile, certificate of age and statement of income supplied by the Guarantor, is found to be false in any way or not in order, the Guarantor shall forthwith pay to the Governors, in cash, the sum of scholarship the student has received from the school and/or the State government/Central government the value of the scholarship he has received for the period the student was at the said school.

8. That if after admission, the student is found to be medically unfit in any way at the time which might, according to the opinion of the appropriate medical authority, render him unfit for his future entry to the Regular Armed Forces, the student will be withdrawn at once, but it would be open to the Guarantor to retain him at the school on payment of the full fee prescribed by the Governors from the date the student is found medically unfit.

9. That the Governors will not be liable for any damages/charges on account of injuries which may be sustained by the student at any time during his stay in the school while taking part in sports or other extra-curricular activities of the school. All expenses that may be incurred in treatment of such injuries will be borne by the parent/guardian as provided in rules of the said school.

10. And that if there is any dispute as to the effect or meaning of these presents or in any way touching or arising out these presents, the same shall be referred to the sole arbitration of the Board of Governors, Sainik Schools, whose decision shall be final.

1 The student shall regularly and diligently pursue his studies at the school and take and go on taking National Defence Academy Examination, so long as his age permits him so to do according to the rules and regulations for the time being in force for entry to the Regular Armed Forces of India, till he is selected therein and when selected the student shall proceed to the institution to which he may be directed for being trained for entry into the Regular Armed Forces.

2. The student shall observe and comply with all the rules and regulations regarding the study, discipline and conduct as may be prescribed by the authorities of the school from time to time.

3. The school shall show diligence in the promotion of his studies at school and strictly confirm to the rules for the award of scholarship framed by the Govt and the instructions which may be issued by the Govt from time to time.

4. That if for any reasons not beyond the control of either the student or the Guarantor, the student fails to pursue his studies at the said school before appearing for selection for entry to any institution, as may from time to time be prescribed by the Govt. for training for entry to the regular Armed Forces or fails to appear for the said selection till such time as his Age permits him to do so, according to the rules and regulations for the time being in forces or having been declared successful at the said selection does not proceed to one of the said institutions to which he may be directed to proceed for being trained for entry into the Regular Armed Forces or fails to join the Regular Armed Forces after completing the training at the said institution, then and if in any such case, the Guarantor shall forthwith pay to the Govt. in cash the sum of scholarship the student has received from the school and/or the State Govt. the value of the scholarship he has received for the period the student was at the said school.

5. The above bounden persons shall communicate any change in his income to the Principal, Sainik School Rewari immediately.

6. The student shall not leave the school at any intermediate stage.

7. On default or break of any of the above mentioned conditions, the above bounden persons shall well and truly repay all money paid to the student on account of scholarship and clothing allowance, if granted, with interest thereon from the date of demand at Govt. rates for the time being in force on the Govt. loan then the above written bond or obligation shall be void, otherwise the same shall remain in full force and virtue.

8. Provided always that if it comes to the knowledge of the Govt. that a scholarship or part thereof has been obtained on the basis of false furnished by the principal the amount of scholarship so obtained shall become immediately re-payable on demand and may be recovered from the principal and the sureties jointly and severally.

9. Provided further that the liability of the sureties under this ground shall not be affected by Govt. giving time or showing any other indulgence to principal and that Govt. may sue the sureties or and them suing the principal, the stamp duty , if any, on this document shall be borne by the Govt.
