1. Your son/ward Master _____ Roll No _____ has been selected for admission to class VI/IX in this school. Admission will be subject to the boy confirming to the prescribed age limit and medical fitness as per application form.

2. You along with your son/ward are to report to this school under your own arrangement **at 0900 hrs on ___ Apr 2019** along with boy's Transfer Certificate (TC), Date of Birth (Issued by Registrar Birth & Death), Category (SC/ST) Certificate/Service Certificate (for defence personal) as per applicable in original and all documents as enumerated in detail in **Appendices – 'A' to 'M'** to this letter. In case of defence service personnel, boy's date of birth (Birth Certificate issued from Registrar Births & Deaths) will have to be supported by the extract of DO Part-II duly signed by the Commanding Officer. In case of ex-servicemen, original along with an attested copy of discharge/pension book containing record of the boy's date of birth is to be submitted. If the boy is born after discharge/retirement from the service, a relationship certificate to this effect duly signed by the Secretary, Zila Sainik Board of the concerned district is to be submitted. The SC and ST certificate where ever applicable should have been issued on the name of boy by the competent authority. The agreement, affidavits and other documents shall be executed & signed by the father of the boy. In absence of father admission documents shall be executed & signed by the mother of the candidate. In case the parents are not alive, such documents will be executed & signed by the legal guardian of the candidate. **In addition, the attested copy of boy's Aadhaar Card will also be submitted. Parents are also requested to ensure that all Vaccinations are done in respect of their ward and details of Vaccination Card of boy be submitted at the time of admission for further action.**

3. In case you fail to report on the aforesaid date and time or report but fail to submit the documents enumerated at Para 2 above, this offer for admission will be withdrawn and suitable candidate from the reserve list in order of merit shall be admitted.

5. Clothing items are provided by the school to the boy for the sake of uniformity. The cost of these clothing items is to be borne by the parents (**Appendix 'N'**). In addition, clothing items as given in **Appendix 'O'** are to be provided by the parents to the boy at the time of joining the school.

6. You are also requested to bring four latest passport size photographs of the boy and two post card size joint photographs of the boy with parents or legal guardian at the time of admission.

7. As per the direction of the Hon'ble Supreme Court, **all kind of ragging is strictly forbidden in the educational institutions.** Parents are requested to advise their ward to desist from ragging activity during his entire stay in the school.

8. Parents are to ensure that the students do not bring with them unauthorized items of clothing and any valuable articles such as gold chain, rings studs etc. **Mobile phones are strictly banned in the school and hostel premises.** Students found in possession any type of mobile phone would be withdrawn from the school. You are requested not to send any eatables, large cash amounts, etc with the student. As such, the school will not entertain any complaint regarding loss of cash amount.

9. At the time of admission, you are required to remit a sum of **Rs.1,16,860/-** (Rupees One Lakh Sixteen Thousand Eight Hundred Sixty only) in case of General & Defence candidates and **Rs. 1,15,360/-** (Rupees One Lakh Fifteen Thousand Three Hundred Sixty only) in case of SC & ST candidates. The amount is to be deposited through Bank Draft only, in favour of "**Principal, Sainik School Rewari**", payable at **Punjab National Bank, District Secretariat, Rewari (Bank Code No.4681).**

AGREEMENT

1. This agreement is made this.....day of Month..... Year..... between Shri.....(hereinafter called the "Guarantor") which expression shall unless excluded by the context or the meaning thereof be deemed to include his heirs, executors, administrators and legal representatives) of the one part and the Board of Governors, Sainik Schools Society (hereinafter called the "Governors") which expression shall unless excluded by the context of the meaning thereof be deemed to include the Principal, Sainik School Rewari of the other part.

2. Whereas.....Son of.....(hereinafter called the student) is son/ward of the Guarantor and has at the request of the Guarantor been selected for admission to the Sainik School Rewari inter alia, on the terms and conditions hereinafter appearing for the purpose of receiving education with a view to making the Regular Armed Forces his profession in life, if considered by the appropriate authority to be suitable and if there is any vacancy and if he be selected.

3. NOW IT IS HEREBY AGREED BY AND between the parties hereto as follows:

4. That in consideration of the student being admitted by the Governors to the Sainik School for the purpose of the aforesaid education at the request of the Guarantor , covenants with Governors that the student will attend the Sainik School regularly and will observe and comply with all the rules and regulations thereof for the prescribed period or until he is declared fit for admission to any institution as may from time to time be prescribed by the Governors, for training for entry to the Regular Armed Forces and that he, the Guarantor shall pay to the Governors regularly and promptly and when ever called upon to do so all the fees as prescribed , if he is not in receipt of any scholarship.

5. That for any reasons not beyond the control of either the student or the Guarantor the student fails to pursue his studies at the said school before appearing for selection for entry to any institution as may from time to time be prescribed by the Governors for training for entry to the Regular Armed Forces or fails to appear for the said selection or in the event of his not succeeding in the said selection , fails to appear for selection , till such time as his age permits him to do so, according to the rules and regulations.

6. For the time being in force or having been declared successful at the said selection, does not proceed to one of the said institutions to which he may be directed to proceed for being trained for entry into the Regular Armed Forces or having joined the said institutions fails to complete the training thereat for entry into the Regular Armed Forces or fails to join the Regular Armed Forces after completing the training at the said institution, then and if any such case the Guarantor shall forthwith pay to the Governors, in cash, the sum of scholarship the student has received from the school and/or the State government/Central government the value of the scholarship he has received for the period the student was at the said school.

7. That if after admission any of the following viz, proof of Domicile, certificate of age and statement of income supplied by the Guarantor, is found to be false in any way or not in order, the Guarantor shall forthwith pay to the Governors, in cash, the sum of scholarship the student has received from the school and/or the State government/Central government the value of the scholarship he has received for the period the student was at the said school.

8. That if after admission, the student is found to be medically unfit in any way at the time which might, according to the opinion of the appropriate medical authority, render him unfit for his future entry to the Regular Armed Forces, the student will be withdrawn at once, but it would be open to the Guarantor to retain him at the school on payment of the full fee prescribed by the Governors from the date the student is found medically unfit.

9. That the Governors will not be liable for any damages/charges on account of injuries which may be sustained by the student at any time during his stay in the school while taking part in sports or other extra-curricular activities of the school. All expenses that may be incurred in treatment of such injuries will be borne by the parent/guardian as provided in rules of the said school.

10. And that if there is any dispute as to the effect or meaning of these presents or in any way touching or arising out these presents, the same shall be referred to the sole arbitration of the Board of Governors, Sainik Schools, whose decision shall be final.

1 The student shall regularly and diligently pursue his studies at the school and take and go on taking National Defence Academy Examination, so long as his age permits him so to do according to the rules and regulations for the time being in force for entry to the Regular Armed Forces of India, till he is selected therein and when selected the student shall proceed to the institution to which he may be directed for being trained for entry into the Regular Armed Forces.

2. The student shall observe and comply with all the rules and regulations regarding the study, discipline and conduct as may be prescribed by the authorities of the school from time to time.

3. The school shall show diligence in the promotion of his studies at school and strictly confirm to the rules for the award of scholarship framed by the Govt and the instructions which may be issued by the Govt from time to time.

4. That if for any reasons not beyond the control of either the student or the Guarantor the student fails to pursue his studies at the said school before appearing for selection for entry to any institution, as may from time to time be prescribed by the Govt. for training for entry to the regular Armed Forces or fails to appear for the said selection till such time as his Age permits him to do so, according to the rules and regulations for the time being in forces or having been declared successful at the said selection does not proceed to one of the said institutions to which he may be directed to proceed for being trained for entry into the Regular Armed Forces or fails to join the Regular Armed Forces after completing the training at the said institution, then and if in any such case, the Guarantor shall forthwith pay to the Govt. in cash the sum of scholarship the student has received from the school and/or the State Govt. the value of the scholarship he has received for the period the student was at the said school.

5. The above bounden principal shall communicate any change in his income to the Principal, Sainik School Rewari immediately.

6. The student shall not leave the school at any intermediate stage.

7. On default or break of any of the above mentioned conditions, the above bounden persons shall well and truly repay all money paid to the student on account of scholarship and clothing allowance, if granted, with interest thereon from the date of demand at Govt. rates for the time being in force on the Govt. loan then the above written bond or obligation shall be void, otherwise the same shall remain in full force and virtue.
